## International Group of Equestrian Qualifications (IGEQ) Coach Passport

**Background:** The International Group for Equestrian Qualifications (IGEQ) is an independent voluntary organisation of worldwide National Equestrian Federations (NFs). The IGEQ has unified equestrian instructor qualifications by producing an agreed matrix of minimum requirements at 3 international levels for 6 disciplines. The passport acknowledges the instructor's qualifications, enabling recognition and acceptance in IGEQ member countries.

The IGEQ Mission Statement is "To develop, promote & maintain equestrian qualifications".

The IGEQ has signed a Memorandum of Understanding with the FEI. In keeping with international trends, this Agreement allows for the cooperation between the two organisations for the betterment of education in the sport of horse riding. IGEQ member federations are also member federations of the FEI.

**Obtaining a Passport:** EA is a member of the IGEQ and members who are at least an EA NCAS Level 1 Coach can apply.

IGEQ passports are valid for up to 10 years provided they are endorsed annually with a NF stamp.

Additional qualifications such as first aid, coach educator accreditation and other professional development relevant to coaching can also be shown on the passport.
