By signing and submitting this International Horse Owner Licence application form you agree to the following terms and conditions:

- 1. You acknowledge the information set out in this application form is true and accurate.
- 2. Should EA believe that the information set out in this application form is incorrect EA reserves the right to cancel the licence and declare the horse's registration invalid.
- 3. You will comply with all applicable EA Rules and Regulations and Bylaws, including the International Horse Owner Licence By-laws.
- 4. Upon notification to you that an International Owner Licence has been issued you must register the relevant horse with the State Branch in which the relevant horse resides.
- 5. If the horse is to be (or has been) imported, a record of its competition history must be provided to the State Branch at the time of its registration with that State Branch. If the person identified as the Responsible Person in this application form is no longer the Responsible Person for the horse you must promptly notify the State Branch as soon as possible.
- 6. The International Horse Owner Licence does not make an International Horse Owner Licensee a Member or Participating Member of EA, or entitle the holder, or the horses registered by the owner, to any benefits or coverage under EA's policies of insurance.
- 7. The International Horse Owner Licence is valid for 12 months from the date of issue.
- 8. The International Horse Owner Licence is not assignable or transferable.
- 9. If you relocate to reside in Australia you must notify EA within one month of arrival into Australia and register as an EA Member. Failure to do so may result in revocation of any registration of horses registered by you and such horses being ineligible to compete in any Australian competition.
- 10. EA reserves the right to cancel an International Horse Owner Licence at any time.
