Create a Horse Management Diary, of your own design, for a 3-month period that leads into a preidentified competition.

The Horse Management Diary must give consideration to, but not be limited to, the following issues;

1) Health and conditioning

Brief details of fitness training and timing of peak fitness, monitoring of vital signs, health checks by Vet, Dentist, Chiropractor or Muscle Manipulation etc, any recording of fitness level by rider and/or coach e.g. heart rate at rest and after fast work, monitoring of recovery times, shoeing and any foot and leg problems. Where there is any treatment needed record brief details.

2) Feeding

Record feeding program for the horse at commencement of the 3-month preparation period then any variations. Include details of supplements fed including electrolytes. Daily water intake should be measured.

3) Travel arrangements

If special preparations are needed for a long trip to the competition record details. Travel sickness precautions should be noted.

4) Event Considerations

Management before, during and immediately after travel should be recorded and also management during the event and on the trip home.

5) Post event

Provide a brief description of the plan for the peak of fitness for the event and the subsequent reduction of workload (ie: between events) or the "letting-down" of the horse for spelling (ie: at the end of the competition season).
