Documents you will need for 2025/2026 Coach Renewal

1	Must either join Marsh insurance or provide a COC Insurance – Equivalent from another provider - \$20 million
2	Need to complete the 2025 Annual Update on Sport Integrity Australia
3	Coach update every 2 years for Coaches and SSTA's and Coach Educator Update every 2 years as a CE. As a Coach Educator you do not need to complete both.
4	First Aid (HLTAID011)
5	Tick Concussion & Incident Reporting Update Box as part of the renewal process
6	Current Working with Children Check

EA ACCREDITED COACH DECLARATION

EA and its affiliated organisations have a duty of care to their members those associated with the sport of equestrian and to the individuals and organisations to whom the EA Policies apply, including the EA Child Safeguarding Policy. As part of this duty of care and as a requirement of the EA Child Safeguarding Policy, EA must enquire into the background of EA Members applying for registration as an EA Accredited Coach.

All EA Members wishing to be registered by EA as an EA Accredited Coach as defined in the National Integrity Framework are required to complete the following declaration.

I Sincerely declare:

1. I have met all the requirements in relation to state specific legislation regarding police checks, working with children checks and attached evidence as required.

2. I do not have any criminal charge pending before the courts, nor any criminal convictions or findings of guilt for offences involving drugs, violence, sexual activity, acts of indecency, child abuse or child pornography.

3. I have not had any disciplinary proceedings brought against me by an employer, sporting organisation or similar body involving child abuse, sexual misconduct or harassment, acts of violence, intimidation or other forms of harassment.

4. I have never been sanctioned for an anti-doping rule violation within any sport.

5. I have never participated in, facilitated or encouraged any practice prohibited by the World Anti-Doping Agency Code or any other anti-doping policy applicable to me, including the EA Anti-Doping Policy.

6. To my knowledge there is no other matter that EA may consider to constitute a risk to its members, employees, volunteers, athletes, or reputation by accepting my EA Accredited Coach registration.

7. I will notify the CEO of the organisation(s) engaging me immediately upon becoming aware that any of the matters set out in clauses [1 to 6] above has changed for whatever reason.

8. I acknowledge that I have read and agree to abide by the EA Code of Conduct for Coaches. I acknowledge I may be subject to disciplinary action if I breach the code. (Code of Conduct is available to view via www.equestrian.org.au)

9. I acknowledge that by signing this declaration I am providing true and accurate information. If it is subsequently proven that the information which I have provided is untrue, false, incomplete, or misleading, then I acknowledge and accept that I may be subject to sanction under EA's applicable rules and policies.)

Note: agreeing to the terms of this declaration fraudulently can result in EA de-registering you as a coach. If you need further advice regarding this declaration, please contact the National Office.
