



EA COACHING COMMITTEE MEETING

Meeting Discussion

Syllabus Review – Discussion around how to progress the Syllabus Review. Sally Barbera to contact Andrew Hamilton seeking direction to progress the Review and then convene a meeting with Committee members to discuss.

Coaching Insurance – Elizabeth Owens requested the Committee put together an insurance wish list. ALL EACC members to go back through previous meeting minutes to identify items for feedback to Elizabeth within next 10 days for presentation to EA Finance Committee.

Simon Kale - the online insurance webinar is not sufficient support to EA Coaches from Gow Gates without face to face presentations from Gow Gates in each state annually and proposed to bring back the annual presentation back.

Update from the EA Pathways Officer – Coaching - written report – taken as read)

Sally Barbera requested Coach statistics to be provided on a state by state basis in the monthly report

Committee agree that ALL committee members to attend a Concussion online webinar. Discussion also around if the concussion training be compulsory for all coaches.

Attending a concussion workshop counts towards coach updating points. Sue Birch to advise Meredith Chapman, NCM, that coaches will be advised to register and provided with the registration link.

IGEQ – Simon Kale is presenting on Risk Management and Safety to the IGEQ in September 2021. The next conference will be held in South Africa and the AGM will be held during the conference.

A few new passports have been issued to EA Coaches currently stuck in the UK. IGEQ passports are meant to be organised in the candidates' country of origin before they leave to go overseas.

Grass Roots Clinic – Sally Barbera shared this initiative which is a collaboration initiative between EVIC Coaching Committee and NSW Coaching Committee as an example of best practice.

Trudy Dougall advised 4 coaches in QLD keen to progress to L3. Sally Barbera advised there had been previous discussion of potentially commencing a L3 course later in 2021. Coaches looking to undertake L3 Coach training need to register their interest in becoming L3 with Sue Birch. Sue Birch to maintain a register of interested potential candidates.

False Advertising by Coaches – who deals with this matter? Simon Kale advised State Offices can send correspondence to any transgressors.

Coaches need to be updated on how to correctly show their EA Coaching accreditations on business cards, letterhead etc. Sue Birch to prepare information piece to be distributed to coaches.

Clarification required around the agreement with EA Board and State CEOs that EA Accredited Coaches in be engaged for State Organised training events. EA to confirm that State CEOs have agreed to use EA accredited coaches at every opportunity possible.

Sue Leslie advised the MPP is being redrafted and will be forwarded to EACC members when final draft is ready.

Sally Barbera advised State delegates that a brief state by state report will be included on upcoming EACC agendas.
