



Equestrian Australia Para Dressage Committee Funding Application

The EAPDC is committed to supporting the growth of Para Dressage and Virtus Dressage. The committee is piloting a support program using the funding available until the end of the current financial year, with grants of up to \$150 available for 15 clubs.

The EAPDC is calling for applications from EA Affiliated Clubs or State Branches to access the available funding. Eligible clubs are encouraged to apply for the purposes outlined below. The intention of this funding is to support state branches and clubs in running Para Dressage classes and, where possible, also include Virtus Dressage classes. Funding may be used to assist with costs such as prizes or Para Dressage officials (e.g. EA Accredited Para Dressage Judges and Para Dressage Stewards) required to run the classes.

Please note that if a club has an outstanding acquittal from previous funding, this must be finalised before any further funding can be released.

Essential Criteria

- Clubs must be currently affiliated with Equestrian Australia.
- To secure funding the competition must be booked for 2026 and invoices received by the 30th of June 2026.
- Proof of purchase and evidence of how the funding was allocated will be required (e.g. tax invoices, receipts, photos, etc.).

Selection Criteria

- Applications will be reviewed on their individual merit by the EAPDC.
- Consideration will be given to ensuring funding is distributed across a range of states and regions.
- Consideration may also be given based on what clubs have previously received EAPDC funding, with the aim of supporting a broader range of clubs.
- Funding decisions will take into account the overall benefit to the development and promotion of Para Dressage and Virtus Dressage.

The purpose of this funding is to support a broad range of clubs across different states and regions, that may require financial assistance to provide Para Dressage and Virtus Dressage opportunities.
