

The following forms are required to be completed in order to maintain your judge accreditation through to 31/3/25

NOTE:

- Rule 12.9 refers to the requirements to remain accredited
- Please note that this re-accreditation period covers 4 years*. e.g. 1/1/18 to 31/03/2022
- Judges who have not met the compulsory requirements may have their accreditation extended for a period of time in order to meet the requirements
- If you have not completed all the prerequisites for re-accreditation, please refer to rule 12.8.1g

*The usual 3 year period has been extended by 12 months due to COVID 19. During this current reaccreditation period you need to have completed the following:

Seminars

- **G to A** – must attend at your level. However, to maintain accreditation G level judges may attend any seminar that includes F level and F level judges may attend any seminar that includes G level
- **Young Horse Judges** – must attend a YH seminar
- **Para Dressage Judges**- must attend a PD seminar
- Only seminars approved by the State JSC or EADOC will be recognised

Workshops

- Must attend at least 2 – these are considered professional development and educational activities and make you a better Judge. Additional seminars may be substituted
- Only workshops approved by the State JSC or EADOC will be recognised
- **Judging** – All levels - due to COVID restrictions resulting in a number of events being cancelled or unable to be held, as long as you have judged **at least 6 competitions, with a minimum of two of these at your highest level** e.g. if D level judge then your highest level is Medium competitions, you will be considered as having met the judging requirement for the current re-accreditation period. For G levels this may include Eventing dressage.
 - **YH** judges will not be required to have judged one YH competition in this reaccreditation period

EA PROHIBITED PERSON DECLARATION – EA Officials

3. I have never been sanctioned for an anti-doping rule violation under any EA anti-doping policy (Athlete or Equine).
4. I have never participated in, facilitated or encouraged any practice prohibited by the World Anti-Doping Agency Code or any other anti-doping policy applicable to me, in the EA Horse Anti-Doping Policy.
5. To my knowledge there is no other matter that EA may consider to constitute a risk to its members, employees, volunteers, athletes or reputation by accepting my EA Official registration.
