

### **EOI to Deliver EA Driving Officials Education**



Equestrian Australia (EA) is seeking Expressions of Interest (EOIs) from people who may be Interested in delivering EA Driving Officials Education.

Submitting an EOI does not guarantee you will be chosen to deliver EA Driving Officials Education. Your EOI will be considered by committee consisting of the Officials Pathway manager and 2 members of the EA Driving Committee and assessed as per the criteria outlined below. The EOI is open until Midnight Sunday 19<sup>th</sup> November AEDT.

#### **Essential Criteria**

- Current member of Equestrian Australia
- Current WWCC or equivalent
- A minimum of three years' current experience as;
  - A current accredited EA Driving Official Level 3 or FEI accredited Driving Official

or

 Current equivalent experience as an Official of the highest level or an accredited Educator from another Driving Organisation

or

- Accredited EA Dressage Officials Educator.
- Experience with or show evidence of an ability to deliver high quality training within an Equestrian Sport discipline that would meet the accreditation needs of Driving Australia.
- Agree to meet all conditions of the Equestrian Australia's Driving Syllabus including the accurate maintenance and submission of records/results and use of your IP.
- Be able to volunteer time and resources to EA affiliated clubs for EA Driving Officials courses
   Education Clinics

#### **Desirable Criteria**

- Train the trainer, workplace training and assessment, education qualification.
- Competed or have extensive experience within the sport of Driving at one or more Official events.
- Willingness to travel and support EA, EA States and affiliated clubs outside of your region.

#### **Personal Attributes**

- High degree of personal and professional integrity.
- A commitment to follow the principles promoted in the EA Officials' Code of Conduct.
- Tact and diplomacy balanced with the capacity to make decisions.
- Ability to maintain confidentiality.
- Good organisational and administrative skills.
- Good communication skills, both written and oral and able to use email communication.
- Good understanding of, and ability to use, online meeting, scheduling, and training options.
