#### **Covid Biosecurity:**

People need to social distance at all times and if this is not possible you must wear a mask. Everyone is to follow hygiene protocols at all times. Everyone will be required to check in using the QLD Government check in app. Please make sure you are registered for use and have downloaded the app prior to attending the grounds, so that check in is instant at the gate upon entry.

#### Horse Biosecurity:

All competitors must hand in their Horse Health Declaration form to the Event Secretary upon arrival. Failure to do so will result in elimination from competition and may affect future attendance of the grounds.

<u>Hendra Vaccination</u>: Please read carefully as it is all competitors responsibility to comply. The minimum requirements for entry are:

1. Hendra Vaccine boosters must have been administered within the previous 12 months OR



2. The first of the two priming doses must have been administered within the previous 2- 6 weeks

- Exemptions will be considered and should be applied for by email to the committee at <a href="mailto:ftpequestrian@gmail.com">ftpequestrian@gmail.com</a>

- Titre tests of a high enough value that are approved by our club vet, will be considered for exemption, however due to the high risk location of the club exclusion tests do not qualify for an exemption at our ODE's

(Note: Horses who have not received any doses of vaccine will not qualify for exemption)

- Microchip numbers are required with the nomination

- Random checks will be conducted throughout the event

- Hendra Vaccination does not replace the requirement for good biosecurity practice and Horse Health Declaration are still required

#### STICTLY NO DOGS ON CROSS COUNTRY AT ANY TIME THROUGHOUT THE ENTIRE

**DURATION OF THE EVENT.** All dogs must always be kept on a leash. Failure to keep your dog on a leash at our events will result in sanction from the club, and potential penalties from Brisbane City Council. Brisbane City Council may be conducting random site visits and the penalty for a dog not on a leash is a \$266.90 on the spot fine. It is also a club bylaw and condition of entry to the event, that all dogs are always to be on a leash, and that no dogs are to be on XC at any time throughout the event. The committee will not tolerate any dogs off leash at the event. You will receive an official warning from the event TD as well as sanction from the club, if you are found with a dog on the XC course at any time throughout the event, or a dog not on a leash in all other areas. This is due to many dogs being let off leash on the xc course, as well as other areas of the venue, at the last event. There is a dog off leash park at the bottom of the club grounds on Fig Tree Pocket Rd which people may utilise. Please also pick up after your dog.

Riders in all classes must be current financial EA members. Horses in EVA95 and above must have current EA membership. Free base registration is available on the EQ website for all other horses. The event will be conducted under FEI and EA rules.

This event is subject to the \$20 EvQ Safety and Course Development fee. There is also a \$20 medical levy charge per rider, for medical services provided at the event.

Attention all competitors and photographers: The official photographer for the event is OzShotz Photography. They have an exclusivity agreement with the club for the entirety of the event. Any other photographers attending the grounds over the course of the event who wish to take photographs of competitors and reproduce them on social media, using images of the club and event competitors, in promoting their own business' or other individuals business', must first obtain consent from the FTPEC committee by email at <u>ftpequestrian@gmail.com</u> Failure to do so may result in sanction from the club. FTPEC grounds is private land and individuals must obtain consent from the club's committee if they wish to conduct photography on the grounds. We appreciate everyone's understanding on this matter as the club wishes to protect everyone's best interests, as well as ensure that we are compliant in our grounds use.

This event is part of the OTTT rewards program:

- Eligible horses can be no more than <u>4 years</u> off the track from the last official trial or race as of <u>1<sup>st</sup> January 2020</u>.
- Riders are to supply their horse's Race Name on entering competitions (which will be checked for eligibility) prior to the event.
- A prize of \$200 will be allocated to the horse with the lowest penalties, \$125 for second lowest and \$75 for third lowest.
- Winners will be given their cash prize after promoting QRIC via social media. Riders are asked to please use the tag @equinewelfareprogram &/or a letter of appreciation to QRIC.

**Presentations:** We will be conducting rolling presentations at the completion of each class on Sunday. We ask that all place getters be present please and that if you receive a prize that you personally thank the sponsor of your class. In order for competitors to receive their prize money, proof of thanks being sent to the class and event sponsor must be provided to the committee first. These events do not happen without sponsors and they need to be thanked via email, a positive google review, or tagged in a social media post for their contributions, and proof of this must be forwarded to the club before prize money will be released. We ask that place getters send this through with their bank details for payment of prize money please.



**Use of Scooters and motorized vehicles at the venue:** The cross country course must be walked on foot only. Permission may be sought from the TD to use a scooter or motorized vehicle for a medical condition.

**Scoring:** We will be using the Nominate system Scoreboard for the event with tablets for the dressage and show jumping phases, and riders will be emailed with their dressage test sheet upon completion of their test.

**Cross country maps:** Will be available online via the Cross Country app, so please make sure you download it.

**Back Numbers:** Riders will be emailed their back numbers prior to the event and are required to print out two copies.

A farrier will be in attendance Saturday and Sunday.

**National Passports** – Please be aware of the National Rules regarding Horse passports. Please click on link for the rulings. Juniors – Please state if a junior when nominating.

LATE FEE – All late entries will incur a \$30 late fee and are non-refundable.

The event schedule will be that same as the last ODE with the CCI1\*, CCI2\* and CCI3\* all showjumping on Saturday afternoon, in daylight hours. Please note some dressage will be on Friday, and some on Saturday. The 1, 2 and 3\* classes will have dressage on the Friday, with the rest on the Saturday. All cross country will be on the Sunday. Please take this into consideration when nominating, thank you. The arrival inspections for FEI horses will be at midday on Friday. Please take this into consideration, thank you.

Refunds: As per Eventing Australia refund policy: Entry fee refunded up to close of entry less 20% admin fee

No refunds after close of entries (Wednesday 30<sup>th</sup> June, 2021), this includes waitlisted entries as waitlisted entries are considered full entries, until advised otherwise.

If the event is cancelled, there will be a 20% administration fee withheld from nominations.

# It is the rider's responsibility to ensure they hold the necessary MINIMUM ELIGIBILTY REQUIREMENTS to enter their desired class. EA rule 517-522.

Any substitution of an entry involving a horse or rider after close of entries will be subject to a \$50 fee, per change, and is at the discretion of the organising committee.

Horses in EVA95 and above must have current EA membership. The event will be conducted under EA rules.



- Classes may be combined or split at the discretion of the Organising Committee.
- Prize Money: As per EA rule 505.3
- Protests must be in writing, accompanied by \$50.

Discount for non members who provide a cross country steward for duration of Cross Country is \$40, this will be refunded once help has been provided. FTPEC members receive a refund of \$35 of nomination fee for providing a minimum of 2 hours assistance at event. This will be refunded after help has been provided.

Please do not leave unused feed or hay anywhere on grounds, it must be placed in bins. We will be enforcing this at this event, and checking yards at 5pm Sunday afternoon. Any feed, hay or manure left in the yard, regardless of the amount, that competitor will not receive their yard bond back.

All manure must be bagged and left in the designated area
