

# HOW DO I BECOME A JUMPING COURSE DESIGNER?

Thank you for your enquiry regarding the steps involved in becoming a Jumping Course Designer.

Course Design is an important part of the school of jumping and a key success factor of good competition.

The development of a competent and experienced Course Designer comes from a long and demanding apprenticeship, building at small, later at medium and then at big national shows. The practical experience of many small shows (and where possible the successful experience of jumping) and the close collaboration with leading national and international teachers are necessary parts of a career to becoming a Course Designer.

The way to becoming a successful Course Designer is long, hard and often bumpy and needs a lot of enthusiasm, passion and patience.

On the other hand, Course Design is a fascinating, rewarding and creative task that should motivate young, open-minded and flexible jumping enthusiasts to be interested in such a career.

State Branches are responsible for the accreditation of officials at Preliminary Level, Level 1 and Level 2. Applications for EA Level 3 officials must be submitted to and approved by the applicant's State Branch who will forward the approved application to the EA National Office and who will facilitate the final approval with the Equestrian Australia Jumping Committee.

The following information has been based on the Equestrian Australia Jumping Rules. EA members applying for accreditation as a Jumping Course Designer must direct their application to the State Branch

### Terminology and Abbreviations:

### Course Designer (CD)

The Course Designer is the person who must put into practice the technical aspects of the different competitions at an event, on the grounds that are well prepared and in good condition, with suitable obstacles, adapting the track to the tables used or to the type of competition scheduled.

### Assistant Course Designer (ACD)

The ACD should support the responsible CD. This is an appointment with the purpose of providing further education, offering additional experience and knowledge. The ACD should be instructed in and be able to:

- Draw official course plans
- Make suggestions about obstacle material
- Make plans for different types of classes according to the event schedule
- Make suggestions regarding heights and distances

- Organise the arena crew
- Measure the length of the course
- Make suggestions for logistic questions, e.g. course changes or jump-offs
- Take part in the course inspection with the CD and the Judges
- Practise co-operation with Judges and Stewards
- Observe the competition
- Analyse the competition after it is finished
- Observe co-operation between the CD and the Organiser and the Media

Entries of the ACD's activity in the logbook to be signed by the responsible CD.

The rules that govern the sport of Jumping are incorporated into the current Equestrian Australia (EA) *National Jumping Rules*. The rulebook may be obtained by the following methods:

#### Article 259.2 Requirements to be an Accredited Jumping Course Designer

- Financial members of EA, who are interested in becoming an Official Jumping Course Designer, must complete and submit an application form detailing their experience and referees according to the criteria for promotion and maintenance on the following pages.
- Upon satisfactory completion of the requirements of each level, you will be accredited as a Jumping Course Designer and added to the National database.
- Accredited Course Designer benefits include insurance cover at EA events, EA support, Officials badge, qualified mentors, available ongoing education, name and contact details on web search and news. Each Course Designer will also receive a letter, certificate, and badge from Equestrian Australia verifying their accreditation.
- In order to remain accredited on the National Course Designers list you must meet compulsory Course Designer activity and professional development requirements every three years. Further information on this can be found on the EA website and will be sent when accredited as a Course Designer.

# The pathway to becoming a National Jumping Judge is outlined in article 259.1 in the National Jumping Rules:

### To become a Preliminary Jumping Course Designer you must:

- be at least 18 years of age
- be a current financial EA member with your State Branch and, in NSW, a current financial member of Jumping NSW.
- Attend an EA approved Jumping Course Designer clinic or seminar held over two days conducted by an Equestrian Australia Jumping Committee approved presenter for introductory or Level 1 course designers and successfully complete the exam requirements as detailed in Attachment 2
- Obtain a score of 5.5 at course plans prepared at the course
- complete the online <u>ASC Community Officiating Essential Skills Course</u>
- meet the practical experience requirements (see Table 1 below) to note EA Jumping events is the whole EA competition not individual classes or days
- Complete the Preliminary application form below and forward it to your state branch
- (Participants do not have to be a member of EA to attend an initial seminar)
- A preliminary course designer can only build to a height of 1.05m and below

### To become a Level 1 Course Designer you must:

- be a member of EA and a current financial member of Equestrian Australia (in NSW also a member of Jumping NSW)
- be at least 18 years of age
- be currently registered as a preliminary Course Designer for at least 1 year

#### or for

Competed annually at 1.30m or above for a period of 4 years

Current EA Registered Level 2 Jumping Coach

- Attend an EA approved Jumping Course Designer clinic or seminar held over two days conducted by an approved EA Course Presenter for a minimum of Level 1 course designers and successfully complete the exam requirements as detailed in Attachment 2
- complete the online <u>ASC Community Officiating Essential Skills Course</u>
- Meet the practical experience requirements (see Table 1 below)
- Complete the application form below and forward it to your State branch

It is recommended that a Level 1 course designer designs courses up to 1.20m

#### To become a Level 2 Course Designer you must:

- be a member of EA and a current financial member of Equestrian Australia (in NSW also a member of Jumping NSW).
- be a currently registered EA Level 1 Jumping CD for minimum of 2 years
- Attend an EA approved Jumping Course Designer clinic or seminar held over two days, conducted by an Equestrian Australia Jumping Committee approved presenter for a minimum of Level 2 course designers and successfully complete the exam requirements as detailed in Attachment 3
- meet the practical experience requirements (see Table 1 below)
- complete the application form below and forward it to your State branch


# It is recommended that a Level 2 course designer designs courses for competitions up to 1.35m.

#### To become a Level 3 Course Designer you must:

- be a member of EA and a current financial member of Equestrian Australia (in NSW also a member of Jumping NSW).
- be a currently registered EA Level 2 Jumping CD for minimum of 2 years
- attend an EA approved Jumping Course Designer clinic or seminar held over two days, conducted by an Equestrian Australia Jumping Committee approved presenter for a minimum of Level 3 course designers and successfully complete the exam requirements as detailed in Attachment 1
- Have been active as a Level 2 course designer for a minimum of two years
- Meet the practical experience requirements (see Table 1 below
- complete the application form below and forward it to your State branch, Once approved this will be forwarded to EA National Office for final approval form EAJC.

# A Level 3 course designer can design courses for all levels of competition unless there is a specific requirement listed.

# WHAT MAKES A GOOD OFFICIAL?

As an official you have to be highly organised and professional. You have to be able to focus, make decisions quickly and firmly, be confident of the training you have received and the knowledge and experience you have acquired as a judge. You must possess diplomacy, tact, common sense and preferably a sense of humour. You have to be able to recognise and acknowledge mistakes you may make whilst officiating and also be able to diffuse a volatile situation.

You are part of a team and if you are the responsible Course Designer, you lead that team. You must be approachable and be able to liaise well with the Judge, the Organising Committee, and other officials and riders.

# As a Course Designer you must **be consistent and fair and have a thorough knowledge of Jumping rules and their application.**

It is important for officials to be:

- Physically fit
- Be able to be consistent and fair from the beginning to the end of the competition
- Mentally alert and able to concentrate for long periods of time

The official must have a thorough knowledge of jumping theory as well as practical jumping training.

#### Your EA membership must be current and both pages of the application form and supporting documents received by the State Jumping Committee before your EA Official registration can be processed. Equestrian Australia Limited (EA) is the Australian national sports organisation for the sport of equestrianism, in each of its specific disciplines and variations (together, the Sport). EA, its Branches (as defined in EA's Constitution), and its affiliated organisations each have a duty of care Your that is owed to their respective members, people associated with the Sport, and to the people and organisations that participate in the Sport conducted under the encouragement, promotion, organisation, Declaration administration and control of EA and its Branches and affiliated organisations. In accordance with the procedures set out in the Constitution, EA has adopted various rules, regulations, by-laws and policies (together the EA Policies) for the purpose of EA pursuing its objectives stated in the Constitution. One of the EA Policies is EA's Child Safeguarding Policy, which commenced into force on 17 December 2021 and which is adopted by EA as part of EA's National Integrity Framework. Any reference in this declaration to the Child Safeguarding Policy is a reference to that document which came into force on 17 December 2023, as amended from time to time thereafter. In accordance with its duty of care, and as required by its Child Safeguarding Policy, EA must investigate and collect information, in relation to any person who makes application for registration as an EA Official. EA requires the submission of this declaration as part of its investigation and information-gathering process. A person cannot be, and will not be registered as an EA Official, unless the person is a current Member of EA. Any person who is a current EA Member, and who wishes to be registered by EA as an EA Official must make and complete the following declaration, in addition to the other requirements set out in the EA Policies governing the registration of EA Officials. NOTE: Any declaration submitted by any person, which is purported to be made by a person with any mark, deletion, addition to, obliteration of, or amendment to any of the below paragraphs [1] to [13] shall be deemed by EA to be a declaration which is void ab initio for all purposes. In any event or circumstances where a person cannot truthfully make the declaration in the format required by this document, the person must contact EA's Integrity Unit to further discuss the matter. I solemnly and sincerely declare that each of the following statements is true and factual as at the date that this Officials Declaration is dated and made by me: 1. I meet all of the requirements in relation to state and territory-specific legislation regarding police checks and working with children checks, and I hold a valid working with children check or equivalent in the state/territory I reside. I have attached evidence as required. 2. There are no criminal charges that have been laid against me in any jurisdiction in Australia or elsewhere, which are pending or which are yet to be determined and finalised. 3. I have never, in any jurisdiction in Australia or elsewhere, been convicted of any criminal offence. Further to the generality of paragraph [3] above, I have never, in any jurisdiction in Australia or 4 elsewhere, been charged with or convicted of any criminal offence involving illegal or illicit substances; violence; stalking; intimidation; dishonesty; sexual violence; any criminal offence involving sexual activity or actions of indecency; child abuse; child pornography; or mistreatment or neglect of a child. 5. I have never had any disciplinary or similar proceedings brought against me by any employer, former employer, sporting organisation or similar body, involving child abuse; sexual misconduct; sexual harassment (which for the avoidance of doubt has the same meaning as given to the term by EA's Member Protection Policy, where the term sexual harassment is defined to mean and include conduct which is any unwanted or unwelcome sexual behaviour, where a reasonable person would anticipate the possibility that the person being harassed would feel offended, humiliated or intimidated); harassment; acts of violence; intimidation; bullying or other similar forms of harassment. 6. I have never been sanctioned for an Anti-Doping Rule Violation (within the meaning given to that term by the World Anti-Doping Code) within the Sport, or any other sport.

7. I have never participated in, facilitated or encouraged any practice, behaviour or conduct prohibited by the World Anti-Doping Code or any other anti-doping policy or similar policy applicable to me, including the EA Anti-Doping Policy and the FEI Equine Anti-Doping and Controlled Medication Rules adopted by EA and amended from time to time.

- 8. I have never been sanctioned for any breach of the FEI Equine Anti-Doping and Controlled Medication Rules or any other rules in force in any sport in Australia or elsewhere, relating to animal doping or the medication of and control of medication given to animals.
- 9. I have never, in any jurisdiction in Australia or elsewhere, been charged with or convicted of any criminal, disciplinary, sporting or animal racing-related offence relating to animal cruelty, whether in relation to a horse or any other animal or creature.
- 10. To the best of my knowledge after due inquiry, there are no other facts, matters or circumstances relevant to me, that EA (if it were aware of those facts, matters and circumstances) may reasonably consider to constitute a risk to, its Branches' and its affiliated organisations' respective members, people associated with the Sport, and to the people and organisations that participate in the Sport under the encouragement, promotion, organisation, administration and control of EA and its Branches and affiliated organisations.
- 11. I will immediately notify the chief executive officer of EA and each Branch(es) and affiliated organisation(s) engaging me, upon me becoming aware of any facts, matters or circumstances meaning that any of the matters declared by me and set out in clauses [1] to [10] above (inclusive) have changed for whatever reason, so that the declaration made by me is no longer true and correct either wholly or to any extent.
- 12. I acknowledge that I have read and agree to abide by the EA **Code of Conduct for Officials**. I acknowledge I may be subject to disciplinary action if I breach the code. (Code of Conduct is available to view via <u>www.equestrian.org.au</u>).

# The EA Code of Conduct for Officials

In addition to the EA General Code of Behaviour, the following requirements are imposed on EA Officials during any activity held or sanctioned by EA, or as an official appointed by the organisation or one of its affiliates:

- Respect the rights, dignity and worth of others
- Be fair, equitable, considerate and honest in all dealing with others
- Use facilities and equipment for their proper purposes and care for and maintain such facilities and equipment correctly
- · Refrain from anything which may abuse, intimidate or harass others
- · Provide a safe environment for training and competition
- Place the safety and welfare of the riders/participants above all else
- Abide by the principles of the FEI Code of Conduct for the Welfare of the Horse
- Maintain a 'duty of care' towards others and an accountability for matters relating to training and competition
- Accept responsibility for all actions taken
- Be impartial
- · Avoid any situation which may lead to a conflict of interest
- Be courteous, respectful and open to discussion and interaction
- Value the individual in sport
- Preserve and protect the standing and reputation of the organisation
- Understand the repercussions if you breach, or are aware of any breaches of the EA Member Protection Policy.

# The FEI Code of Conduct for the Welfare of the Horse

- The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.
- 2. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
- 3. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
- 4. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
- 5. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.

The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.
