Background: The International Group for Equestrian Qualifications (IGEQ) is an independent voluntary organisation of worldwide National Equestrian Federations (NFs). The IGEQ has unified equestrian instructor qualifications by producing an agreed matrix of minimum requirements at 3 international levels for 6 disciplines. The passport acknowledges the instructor's qualifications, enabling recognition and acceptance in IGEQ member countries.

The IGEQ Mission Statement is "To develop, promote & maintain equestrian qualifications".

The IGEQ has signed a Memorandum of Understanding with the FEI. In keeping with international trends, this Agreement allows for the cooperation between the two organisations for the betterment of education in the sport of horse riding. IGEQ member federations are also member federations of the FEI.
