## Nomination for Election - Rider Representative

The World Cup Committee of the Australian League is calling for nominations for the role of the Australian League World Cup Jumping Riders Representative for the period 2016-2018

The main responsibilities of the Riders Representative are:

- Attend two Australian Jumping World Cup Committee meetings, held in Sydney usually during February and August of each year.
- Supply a written riders representative report for each of the Australian Jumping World Cup meetings.
- Attend, where possible, each of the qualifying rounds of the Australian League World Cup events
  (CSI-W). If you are unable to attend a qualifying round, you will be required to arrange for a suitable
  person to act as the Rider's Representative for that round.
- Inform (via EA office) the organising committee of each CSI-W who the Riders Representative will be and their contact telephone number.
- At the CSI-W approach the organising committee and let them know that you are on site and available if there are any issues regarding the CSI-W.
- Make sure the CSI-W nominated riders know that you are the riders representative for that class and you will deal with any OC issues on their behalf.
- Observe and make sure correct and safe equipment is used on course and in the warm up.
- Walk the course and be on hand to handle any rider issues.
- Make sure there is an appointed FEI steward at the warm up arena.
- Following the CSI-W complete the 'Riders Representative's' report which reports on the venue, program, footing, equipment, course design, organising committee, warm up area, and room for any additional comments.
- If you are not the Riders Representative, you must collect the Riders Report from the representing rider.
- At each of the Australian Jumping World Cup Meetings supply the Riders Reports from the CSI-W's held so far in the season.

The skills and knowledge required for the role:

- High Level Competition Experience
- Solid understanding of the FEI and EA World Cup rules.
